
Stephens & Johnson Operating Co. request administrative approval of a non-standard location for our E. O. Carson No. 27 well located at 2050 feet from the north line and 1553 feet from the west line of Section 33, T21S, R37E in Lea County, New Mexico.

The well will be a producer in the Penrose-Skelly-Greyburg Field (Pool Code 50350) which is an oil pool spaced on 40 acres. The non-standard location is needed since the well is located 233 feet from a unit line. The well is located 590 feet from the south line and 1553 feet from the west line of the E. O. Carson lease.
