COG proposes to drill a **DIRECTIONAL** SE /4, 40 acre spacing
Maljamar; Yeso oil well
TD of approximately 7100'

Location: 745' FSL & 1330' FEL Sec 20, T17S, R32E, Unit O

This well had to be drilled at a non-standard location due to sand dunes.

The plan for this well is to complete it in the Yeso formation.
We won't know the exact perms until we drill & log it, but it will be very similar to
the G C Federal #5 (2210' FSL & 330' FWL, Section 19, Lot 3) which was
completed in February 2005.

The G C Federal #5 completion broke the Yeso up into 2 perf/stimulation
intervals from: 6360' – 6929'.

1st interval: 6360' to 6553',
acidized w/ 3000 gals,
frac'd w/ 90,006 gals gel, 8,000 # LiteProp, 89,420# 16/30 sand.

2nd interval: 6799' – 6929',
acidized w/ 2500 gals,
frac'd w/ 90,681# gal gel, 8000# LiteProp, & 87,020 gals 16/30 sand.

At this time, we assume the G C Federal #29 should be very similar.
