
The New Mexico Oil Conservation Division District 2 Office (OCD) is in receipt of a remediation work plan for the above referenced facility.

The work plan is approved with the following stipulations:

- Results of analytical data obtained through sampling shall be forwarded to OCD for approval **prior** to any backfilling activities
- A final Report C-141 is to be submitted to the OCD upon satisfactory completion of remediation project.
- Remediation requirements may be subject to change as site conditions warrant.
- Remediation activities to be completed on or before **January 20, 2009**.

Please be advised that NMOCD acceptance of a C-141 does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that pose a threat to ground water, surface water, human health or the environment. In addition, NMOCD acceptance of a plan does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.

Our plan for the remediation of the affected portion of the location is as follows:

Visible water was vacuumed from the site on the day of incident.

Contaminated material was removed 12/5/08  
Contaminated material will be transferred to LeaLand facility.



We want to schedule soil sampling for 12/16/08 at 9:00 am.

Soil samples will be taken from the depression at 1 foot and 2 foot levels.  
Soil samples will be tested by Cardinal Laboratory, Hobbs, NM for:

TPH  
BTEX  
chlorides

If soil samples are satisfactory, fresh soil will be brought in to fill.  
If soil samples are not satisfactory, excavation and sampling will continue until satisfactory
