Dear Mr. Brooks:

Marbob Energy Corporation requests approval for the N B Tween State #6 unorthodox location described above. The location was originally staked at 2310' FNL 1650' FWL at an orthodox location. This location was determined to be unusable because there was an El Paso Buried Gas Line and a Duke Buried Gas Line running approx. 20 feet from our center hole. Moving the location north put us on an existing Lime Rock well and west still keep us on the pipeline. We reviewed alternate possible locations and determined a location of 2400' FNL 1540' FWL would provide the closest location. This location is unorthodox and we are requesting permission to drill this footage.

The formation that we will attempt and believe we will complete in is the Yeso formation. This formation is currently contained in the Artesia Glorietta Yeso pool. We are the operator of all of the offsetting proration units in this pool. Enclosed is a copy of form C-102 showing the location and proposed proration unit. As an abundance of caution we have notified all of the working owners in each tract as to the Yeso formation since there are some differences in ownership between the various parties in the offset proration units. Also, enclosed is a map showing the proposed proration unit and the offset proration units. The operator(s) in these affected and offset unit in the Artesia Glorietta Yeso pool is Marbob Energy Corporation.


