
Describe Cause of Problem and Remedial Action Taken. *

A Six inch gathering line had a leak and released gas and any produced liquids that were lying in the line. Line was repaired and possibly contaminated soil used for backfill. The line has since been taken out of service.

The old pipe in the contaminated area has been removed and capped. 60 yards of contaminated soil was excavated and hauled to an approved OCD landfill. New soil was purchased from landowner to backfill. The area has been cleaned and tested per OCD Guidelines.
