

Encore Operating, L.P. here by request NMOCD administrative approval for a non-standard location. Encore drilled this well and the bottom hole location ended up to be located 628' FNL & 1030' FEL of Sec. 30-22S-37E. The original original non-standard exception was granted on June 2, 2008 with location anticipated being 742' FNL & 1294' FEL, Sec. 30-22S-37E. Encore is producing from the Blinebry(5535') & Dinkard(6621') formations.

Based on statewide rules (40 acre proration unit and 330 unit line), this location is a non-standard location.


