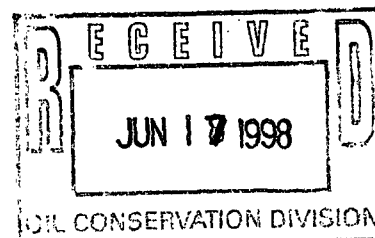

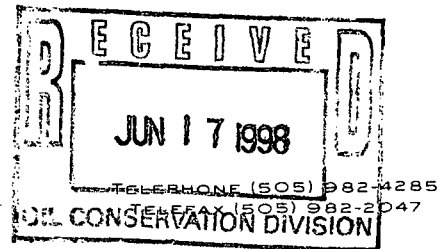

Comes now NEARBURG PRODUCING COMPANY ("Nearburg") by and through its attorneys, KELLAHIN and KELLAHIN, and applies to the New Mexico Oil Conservation Division ("NMOCD") for an exception to Division Rule 104 and for approval of a Directional Wellbore in accordance with Rule 111 to permit it to re-enter the Cities Service Little Box Canyon Well No. 4 which is located at a standard surface location ~~1647~~ ¹⁶⁵⁰ feet from the East line and ~~1924~~ ¹⁹⁸⁰ feet from the North line and to directionally drill it to an unorthodox bottom hole location to a point in the top of Morrow "C" formation of the Little Box Canyon-Morrow Gas Pool being a point not closer than 990 feet from the north line or 660 feet from the east line (Unit A) of Section 12, Township 21 South, Range 21 East, NMPM, Eddy County, New Mexico, to be dedicated to a 320-acre gas spacing unit consisting of the N/2 of said Section 21, said location being unorthodox for any and all gas production from any and all formations/pools spaced on 320-acres including but not limited to the Little Box Canyon-Morrow Gas Pool

In support thereof, Applicant states:

1. Applicant, Nearburg, has the right to drill and develop hydrocarbons in the N/2 of Section 12, Township 21 South, Range 21 East, NMPM, Eddy County, New Mexico.
2. Nearburg proposes to re-enter the Cities Service Little Box Canyon Well No. 4 which is located at a standard surface location 1650 feet from the East line and 1980 feet from the North line and to directionally drill it to an unorthodox bottom hole location to a point in the top of Morrow "C" formation of the Little Box Canyon-Morrow Gas Pool being a point not closer than 990 feet from the north line or 660 feet from the east line (Unit A) of Section 12, Township 21 South, Range 21 East, NMPM,

Eddy County, New Mexico, to be dedicated to a 320-acre gas spacing unit consisting of the N/2 of said Section 12, said location being unorthodox for any and all gas production from any and all formations/pools spaced on 320-acres including but not limited to the Little Box Canyon-Morrow Gas Pool.

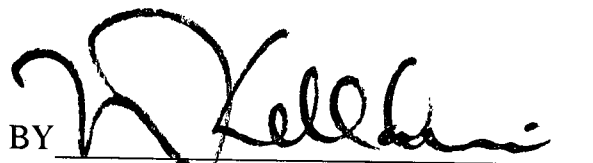
4. Said well will be drilled within the current boundaries of the Little Box Canyon-Morrow Gas Pool.

PLANE OF VERT SECTn N45 00E

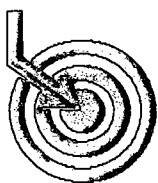

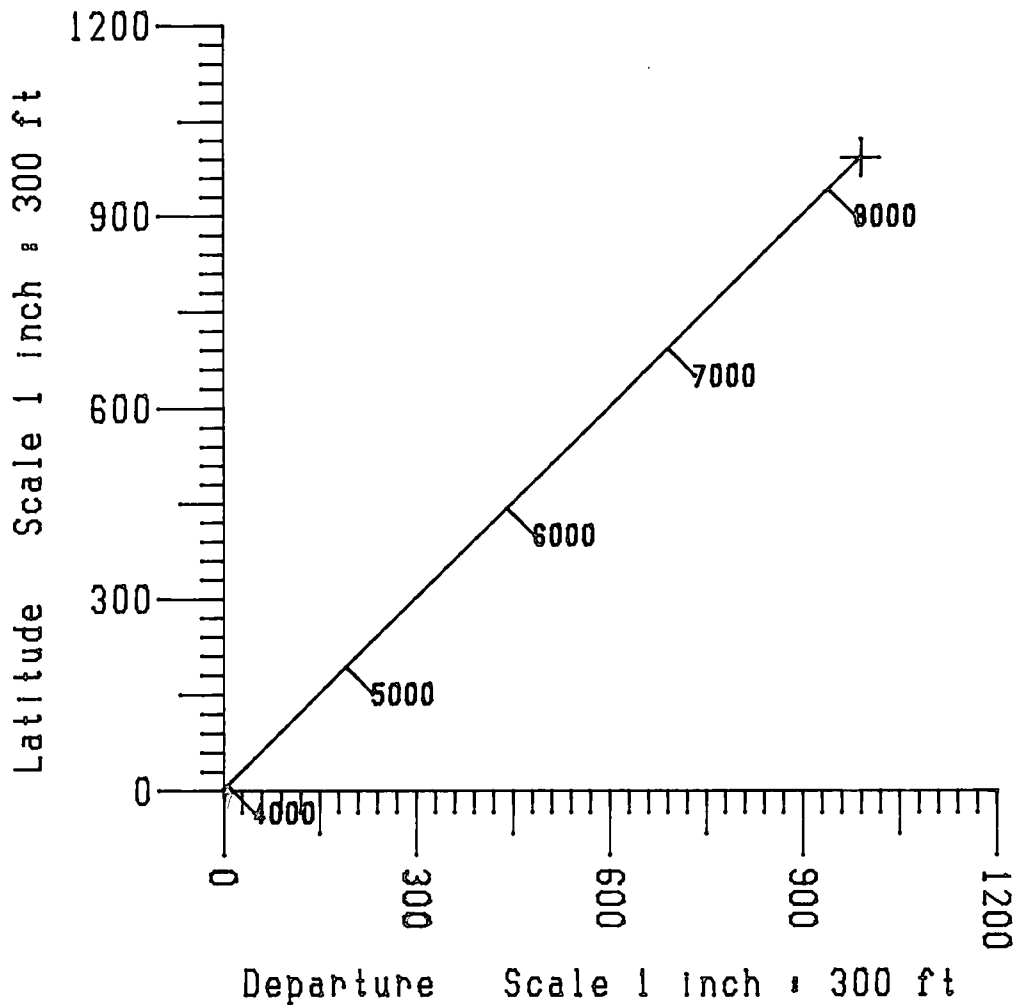
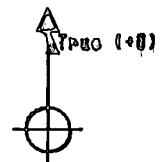

PLANE OF VERT SECTn N45 00E

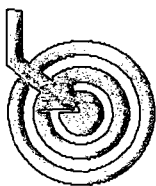
