Dear Ms. Bradfield:

Reference is made to your application submitted to the New Mexico Oil Conservation Division ("Division") on July 1, 1998 for an exception to the well location requirements provided within the "*Special Rules and Regulations for the Blanco-Mesaverde Pool/Special Rules and Regulations for the Basin-Dakota Pool*," as promulgated by Division Order No. R-10987, for Burlington Resources Oil & Gas Company's ("Burlington") proposed San Juan "28-4" Unit Well No. 32-M to be drilled at an unorthodox infill gas well location in both the Blanco-Mesaverde and Basin-Dakota Pools 2030 feet from the South line and 2470 feet from the East line (Unit J) of Section 32, Township 28 North, Range 4 West, NMPM, Rio Arriba County, New Mexico.

Gas production from the Blanco-Mesaverde Pool is to be included in an existing standard 320-acre lay-down gas spacing and proration unit comprising the S/2 of Section 32, which is currently dedicated to Burlington's San Juan "28-4" Unit Well No. 9 (API No. 30-039-07233), located at a standard gas well location 1150 feet from the South line and 1600 feet from the West line (Unit N) of Section 32. Gas production from the Basin-Dakota Pool is to be included in an existing standard 320-acre stand-up gas spacing and proration unit comprising the E/2 of Section 32, which is currently dedicated to Burlington's San Juan "28-4" Unit Well No. 32 (API No. 30-039-20174), located at a standard gas well location 1617 feet from the North line and 870 feet from the East line (Unit H) of Section 32.

The application has been duly filed under the provisions of Division Rules 104.F and 605.B of the General Rules and Regulations of the New Mexico Oil Conservation Division ("Division").

By the authority granted me under the provisions of Division Rule 104.F(2), the above-described unorthodox Basin-Dakota/Blanco-Mesaverde infill gas well location for the San Juan "28-4" Unit Well No. 32-M is hereby approved. All of the aforementioned wells and both spacing units will be subject to all existing rules, regulations, policies, and procedures applicable to prorated gas pools in Northwest, New Mexico.
