



John H. Hendrix Corporation has recompleted the Elliott B-15 No. 7 in the Blinebry (Pro Gas) Pool. It is our desire to simultaneously dedicate the existing 160-acre Blinebry Gas proration unit currently assigned to our Elliott B-15 No. 4 to include the Elliott B-15 No. 7. The 160-acre gas proration unit comprises of the NE/4 of Section 15, T22S - R37E, Lea County, New Mexico.

As a result, the Elliott B-15 No. 7 located 330' FSL and 660' FWL, Unit G, Section 15, T22S - R37, Lea County, New Mexico is unorthodox. A Penrose Skelly well was drilled at the normal location.
