Dear Mr. Roe:

Reference is made to your application dated January 17, 2007 to surface commingle the Kingfish No. 1, Kingfish Com No. 90 and Kingfish Com No. 90S, and to add the Kingfish No. 1 well to the existing Kingfish Com No. 90 CDP. On March 23, 2007, I sent a letter of approval but I incorrectly listed the application date as January 17, 2006 instead of January 17, 2007. Please note that I corrected the application date in my records and will notify NMOCD that I referenced the wrong application date in my approval letter.

Again, I want to assure you that approval is hereby granted for surface commingling for the Kingfish No. 1, Kingfish com No. 90, and the Kingfish Com No. 90S as requested in your application. All wells will maintain an allocation meter on location and meet the requirements as set by Onshore Order #5. The CDP meter shall also follow the requirements as set by Onshore Order #5 and must be calibrated quarterly. Any new wells added to the gathering system must be applied for separately.

Approval of this surface commingling process will be monitored on a continual basis by BLM to evaluate the benefits for royalty determination. This office reserves the right to rescind this approval should future evaluations indicate that royalties would be reduced or production accountability compromised.

With regard to your request in the application referencing notice requirements, for future additions to the gathering system, only the interest owners to be added will require notification, provided the proposed system will not adversely affect the existing wells.

Dear Mr. Roe:

Reference is made to your application dated January 17, 2006 requesting approval to surface commingle and add the Kingfish No. 1 well to the existing Kingfish Com No. 90 CDP, which also includes the Kingfish Com No. 90S well. The Kingfish Com No. 90 CDP was approved by the Farmington Field Office on September 12, 2006.

Since the gas line connecting the Kingfish Com No. 90S to the Kingfish Com No. 90 passes through the location for the Kingfish # 1, it will allow the No. 1 well to utilize the compressor currently installed for the other wells, keeping wellhead pressures as low as possible, and allow for recovery of more gas.

Approval is hereby granted for surface commingling as requested in your application. All wells will maintain an allocation meter on location and meet the requirements as set by Onshore Order # 5. The CDP meter shall also follow the requirements as set by Onshore Order # 5 and must be calibrated quarterly. Any new wells added to the gathering system must be applied for separately.

Approval of this surface commingling process will be monitored on a continual basis by BLM to evaluate the benefits for royalty determination. This office reserves the right to rescind this approval should future evaluations indicate that royalties would be reduced or production accountability compromised.

With regard to your request in the application referencing notice requirements, for future additions to the gathering system, only the interest owners to be added will require notification, provided the proposed system will not adversely affect the existing wells.
