Also attached is form C-145 showing that COG Operating LLC assumed operations 1-1-09 of the Tracey Federal #1.

COG is rapidly pursuing implementation of this SWD. We are constructing the surface facilities at the present time.

However, our field representative reported that we are waiting on a right of way to lay a water line.

COG Operating LLC respectfully requests permission to have a three month extension granted to insure that we can complete all construction and begin injection before the order expiration date.
