
On November 28, 2006 the Bureau of Land Management (BLM) advised this office of their approval to the revision of the subject participating area.

Please advise all interested parties of this approval. Pursuant to your meeting with our staff on October 5, 2007 our approval is contingent upon Strata Production Co. spudding a well in Section's 9, 10 or 15-23S-30E on or before April 30, 2008. Failure to timely spud a well to explore the expanded participating area by April 30, 2008 will be cause for rescinding our approval of this application.
