The ultimate goal of NSL Blanket is to develop the land in an orderly fashion and maintain steady production, and also prevent unnecessary waste, while protecting the correlative rights of all parties involved.

Under this agreement the well shall be staked no closer than 790' from outer boundary line of the acreage involved (Figure A) and no closer than 10' to each  $\frac{1}{4}$   $\frac{1}{4}$  line (Figure B). Each developmental well of a defined pool must be located on an 160 acre spacing. This agreement will allow Mallon Oil Company to increase vertical limits from surface to the Mesa Verde formation and accommodate all agencies with surface concern.

## RESOLUTION OF THE TRIBAL COUNCIL

OIL AND GAS ADMINISTRATION

RE: MALLON OIL COMPANY - MINERAL DEVELOPMENT AGREEMENT

RESOLUTION NO. 98-R-236-05

WHEREAS, the Tribal Council is the governing body of the Jicarilla Apache Tribe and is vested by the Revised Constitution with the authority to control the development of the oil and gas resources of the Reservation; and

WHEREAS, the Indian Mineral Development Act of 1982 authorizes the Jicarilla Apache Tribe, with the approval of the Secretary of Interior, to enter into negotiated agreements for the development of oil and gas resources of the Tribe held in trust by the United States; and


WHEREAS, the Oil and Gas Administration of the Tribe has negotiated a Minerals Development Agreement with Mallon Oil Company for the exploration and development of oil and gas on Reservation lands not now subject to any oil and gas lease or other development agreement; and

WHEREAS, the Tribal Council has reviewed the negotiated agreement, a copy of which is attached to this resolution, and has determined that the agreement complies with applicable Tribal laws and policies and is in the best interests of the Tribe.

NOW, THEREFORE BE IT RESOLVED, by the Tribal Council of the Jicarilla Apache Tribe that the attached Minerals Development Agreement with Mallon Oil Company is hereby approved by the Tribe, subject to review and approval by the Secretary of the Interior as provided by the Indian Mineral Development Act of 1982.
