XTO Energy, Inc. requests administrative approval for surface commingling and off-lease measurement of natural gas produced from the above listed wells operated by XTO Energy, Inc. The FRPC #22-2 is located in Section 21E, 29N 13W. FRPC #22-3 is located in Section 22M, 29N 13W. Both wells are Fruitland Coal wells only. LSP

XTO plans to produce both wells through a centralized compressor, thus reducing costs and minimizing the noise and footprint in the surrounding area. To determine allocations for production and fuel usage, each well will have a gas and water meter on the location, which will be maintained by XTO Energy, Inc. FRPC #22-2 currently has an electric pumping unit installed. The shared compressor will be powered by electricity. Produced water will be surface commingled and stored on the FRPC #22-2 location.

All interest owners have been notified by Certified Mail, return receipt, dated March 27, 2009.

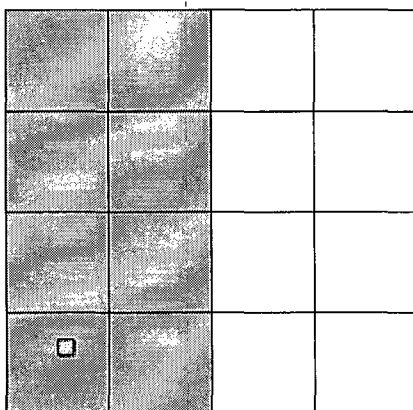

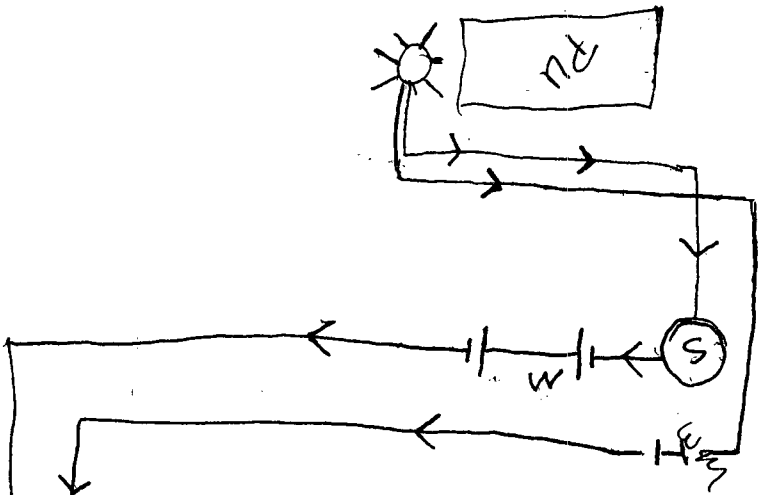

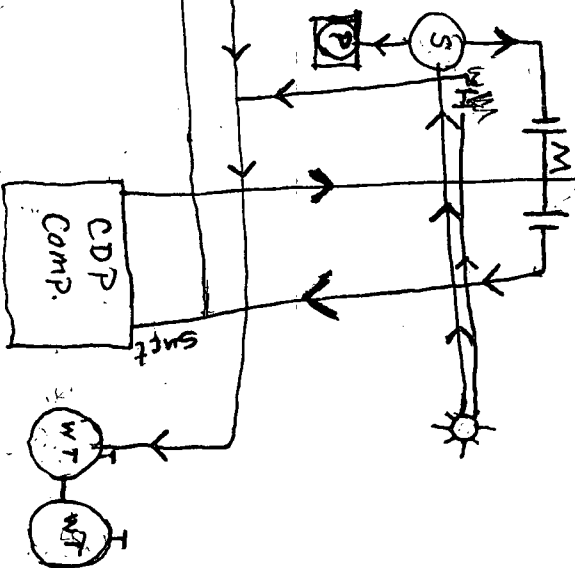
