Reference is made to the following:

(a) your application (**administrative application reference No. pKAA09-14949455**) submitted to the New Mexico Oil Conservation Division (the Division) in Santa Fe, New Mexico on May 29, 2009, and

(b) the Division's records pertinent to this request.

Williams Production Co. LLC [OGRID 120782] (Williams) has requested to complete the above-referenced well as a directional well having its surface location as described in the caption of this letter, at an unorthodox bottom hole location in the Mancos formation, 402 feet from the South line and 438 feet from the West line (Unit M) of Section 11, Township 31 North, Range 6 West, in Rio Arriba County, New Mexico. The W/2 of Section 11 will be dedicated to this well in order to form a standard 320-acre gas spacing unit in the Basin Mancos Pool (97232). Spacing in this pool is governed by the Special Rules for the Basin-Mancos Gas Pool, as promulgated in Order R-12984, issued on September 3, 2008, which provide for 320-acre units, with wells located at least 660 feet from a unit outer boundary. This location is less than 660 feet from the western and southern unit boundaries.

Your application has been duly filed under the provisions of Division Rules 15.13.C and 4.12.A(2).
