Bob,

This release that occurred on 6/1/09 (Discovery date: 6/2/09) is being tracked under API # 30-015-26698 and has been assigned admin permit # 2RP-321.

NMOCD District 2 office is in receipt of the Final Report C-141 submitted for this release. Some clarification is requested regarding the Chain of Custody document from the lab. A note on the document indicates some head space present in the samples. It appears to have been crossed out. Please confirm whether or not the sample containers contained head space or not. Also noted was the temperature of the samples upon receipt by the lab. The temperature is elevated for BTEX samples.

In addition, it was noted that the samples submitted were tested for chloride constituents. The analyses for the chlorides was not submitted with the closure request. Closure for this site cannot be approved at this time without a review of the chloride analyses. Please submit this analytical data for OCD review not later than June 26, 2009.

NOTE: The Final Report C-141 will not be denied at this time, but will be held pending a review of the data.
