The total overall volumetric CDP reading shall be the sum of the volumetric readings from the the four (4) CDP's which shall be used to allocate production back to individual wells. Gas is approved for off lease measurement and sales after being metered on-lease.

Yates Petroleum Corporation is also authorized to add prospective additional leases and wells from the following lands without additional notices to the owners of interest in the original wells as long as the wells being added produce from the Pools listed on page one (1).

T-24-S, R-29-E, Sections 3, 4, 8, 9, 12, 13, and 20

T-25-S, R-28-E, Section 36

T-25-S, R-29-E, Sections 1, 12, 20, and 29

T-25-S, R-30-E, Sections 5, and 6.

In seeking to add additional leases and wells to this commingling authority, Yates shall apply formally to the Santa Fe Office of the Division, and notice shall only be given to those interest owners in the leases or wells to be added.

It is the responsibility of the producer to notify the transporter of this commingling authority. The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.

This Order supersedes the commingling Order Nos. PLC-309, PLC-309-A, PLC-310, and PLC-310-A which were consolidated and combined into this Order.
