## Gentlemen:

Reference is made to your letter dated December 21, 1955, requesting cancellation of NSP-207 dated November 30, 1955, for 120 acres. You requested cancellation of that NSP in the N/2 NW/4 and SW/4 NW/4 of Section 22, Township 21 South, Range 36 Bast, Eumont Gas Pool, due to delay in communitizing said acreage. Administrative Order NSP-207 is hereby cancelled as per your request.

Administrative Order NSP-187 dated September 21, 1955 for 80 acres for your State "I" Well No. 2, consisting of the N/2 of the NW/4 of said section 22, is still valid and may be used while you are negotiating communitization of the entire NW/4 of said Section 22.
