Re: Request for Non-standard  
Proration Gas Unit

Gentlemen:

In accordance with Order R-520 the undersigned hereby requests a non-standard unit consisting of 160 acres in Lea County, New Mexico, as follows:

1. The complete legal description of acres included in the proposed unit: NE 1/4 Section 29, Township 20 South, Range 36 East, Lea County, New Mexico, containing 160 acres.
2. J. Don Hudgens, Inc., <sup>Sims =</sup> State #1 (formerly drilled as Southern Petroleum Exploration, Inc. - Two States Oil Company - State #1; plugged and abandoned June 27, 1955) completed gas well is located 1980' from the east line and 660' from the north line of Section 29.
3. Flat is attached showing acreage to be included in the unit and all off-set lease ownership.
4. It is the intention of the operator to produce the gas well from the Seven Rivers formation as a non-standard gas unit comprising 160 acres in the West Eumont gas pool.
5. According to structural contours on top of the Seven Rivers gas zone it is expected that all of the acreage in the unit is gas productive.
6. Copies of this request for non-standard proration gas unit have been mailed to all of the off-set operators as listed below.


