Dear Sir:

Your application to form a 160-acre non-standard gas proration unit, dated August 25, 1955 was received in this office on August 29, 1955. Your application is for the SW/4 of Section 32, Township 21 South, Range 36 East, Jalmat Gas Pool, Lea County, New Mexico, for your Pech-State Well No. 1.

It is noted that you failed to notify Cities Service Oil Company of your application. It is also noted that you notified Continental, Gulf and Late Oil Company, but it did not indicate that the notification was by registered mail. See enclosed memorandum on this procedure.

Have you received written permission from the State of New Mexico Land Office, Pech Oil Company and/or Shell Oil and El Paso Natural Gas Company for this communitization of gas interests for a gas well to be drilled? Please inform us by return mail of these agreements.

Gentlemen:

In accordance with Order R-520 the undersigned hereby requests a non-standard gas unit consisting of 160 acres in Lea County, New Mexico as follows:

1. The complete legal description of acreage included in unit is: SW/4 of Section 32, Twp. 21S, Rge. 36E, Lea County, New Mexico containing 160 acres.
2. The J. H. Moore, Pech-State #1 is being drilled at a location 990' from the West line and 1,650' from the South line of Section 32. This well is to be completed as a dry gas well from the Yates formation from the approximate depth of 3,300' to 3,450'.
3. This gas well will be within the vertical limits of the Jalmat Pool.
4. Plat is attached showing acreage to be included in the unit, the well location and all offset lease ownership and completed wells.
5. Copies of this request for a non-standard proration gas unit have been mailed to all of the offset operators as listed below.


