Re: Non-Standard Gas Proration Unit, Jalmat Gas Pool, Lea County, New Mexico

Gentlemen:

It is respectfully requested that the Conservation Commission approve our application for a 320 acre non-standard gas proration unit embracing the W/2 Sec. 2-24S-36E, Lea County, New Mexico, and to be assigned to the State "AS" No. 1.

Cities Service and the Humble Oil and Refining Company have entered into a gas operating agreement to provide for the gas development of the west half Sec. 2-24S-36E with Cities Service owning 75% and Humble 25%. Cities Service will operate the unit.

In support of this application, we wish to state the following:

1. The State "AS" No. 1, located 1980' from the north and west lines of Sec. 2-24S-36E, has been completed as a gas well from within the vertical and horizontal limits of the Jalmat Gas Pool.
2. This non-standard gas proration unit consists of contiguous quarter/quarter sections within a single governmental section, and the entire unit may reasonably be presumed to be productive of gas.
3. Waivers have been mailed to all operators in Section 2 and within 1500' of the unit well, with requests that they be mailed to the Conservation Commission should they have no objection to the formation of this unit.
4. A plat of the area indicating the proposed non-standard gas proration unit and offset ownership is attached.




