Describe Cause of Problem and Remedial Action Taken.\* Monday evening or Tuesday morning lightning struck the tank battery and fiberglass water tank on the above mentioned well. Fluid levels were checked the day before with an estimated 18-20 barrels of water and 9-10 barrels of oil at the time of fire. All of the oil stayed in the steel tank and burned up. With the significant rainfall it is difficult to determine how much (if any) water ran off the location.. Clean up of the tank batteries began on 7/7/09.

Describe Area Affected and Cleanup Action Taken.\*  
Most if not all of the fluids stayed on location. Other than removal of tank batteries and some soil excavation little clean up has been done. Soil samples will be completed and once data is reviewed an agreed upon clean up will be conducted.
