Gentlemen:

Reference is made to your application for approval of a 160-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the following acreage:

Township 20 South, Range 36 East, NMPM
NE/4 of Section 13

Y
It is understood that this unit is to be ascribed to your M. T. Orcutt "D" (State) Well No. 1, located 1980 feet from the north and east lines and in the SW/4 NE/4 of Section 13, Township 20 South, Range 36 East, NMPM, Lea County, New Mexico.

By authority granted me under provisions of Rule 5, Section (b)-6 of the Special Rules and Regulations for the Eumont Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 160 acres. The allowable shall be effective the first day of the month following the receipt of an affidavit from you indicating the consummation of the communitization agreement of the working interests and the State of New Mexico Land Office.
