Re: Application to Dually Complete and to establish
a 80 acre Nonstandard Proration Unit in the
Blinebry Gas Pool for Sinclair's J. R. Cone "A"
Well No. 2 in Section 26-21S-37E, Lea County,
New Mexico.

Gentlemen:

Sinclair Oil & Gas Company wishes to make this application for administrative approval under Order R-316, Rule 112A, to dually complete their J. R. Cone "A" Well No. 2 in the Blinebry Gas Pool and the Drinkard Oil Pool (present zone).

Sinclair also wishes to make application for administrative approval under Order R-610 for a Nonstandard Proration Unit consisting of 80 acres and located in the W/2 of the SW/4 of Section 26-21S-37E, Lea County, New Mexico to be assigned to subject well.

In the above matters Sinclair wishes to state:

1. Sinclair Oil & Gas Company is the operator of the J. R. Cone "A" No. 2 Well which is located in the center of the NW/4 of the SW/4 of Section 26-21S-37E. This well was completed as an oil well in the Drinkard Oil Pool on May 20, 1947, at a total depth of 6,565 feet. Seven inch casing was set at 6553 feet and cemented with 400 sacks and perforated in the Drinkard Oil zone from 6404 to 6414 and from 6475 to 6550 feet.
2. Sinclair proposes to dually complete subject well in the following manner:
 - a. Perforate the 7" casing from approximately 5500 feet to 5700 feet in the Blinebry Gas Pool.
 - b. Set a production packer below the Blinebry perforations at about 6300 feet to separate the two pay zones.
 - c. Produce the Blinebry gas through the casing-tubing annulus and the Drinkard oil through the tubing.

3. Sinclair will comply with all the rules and regulations of the Commission applicable to dual completions and the separation of pay zones.
4. Sinclair believes that the manner and method of this proposed dual completion is mechanically feasible and practical.
5. The Nonstandard Gas Proration Unit to be assigned subject well consists of two contiguous quarter-quarter sections and is described as the W/2 of the SW/4 of Section 26-21S-37E, Lea County, New Mexico. The well is located 660 feet from the West and North lines of the unit. The length or width of this unit does not exceed 2640 feet and it lies wholly within a single governmental quarter section. The royalty interests and the leasehold interests are common under the unit. Subject unit may reasonably be presumed to be productive of gas from the Elinebry Gas Pool.

Sinclair believes that the granting of this application is in the interest of conservation and the protection of correlative rights.

Sinclair has notified all offset operators as defined in Orders R-316 and R-610 of this application by copy thereof via registered mail. Said operators are listed on next page.

Sinclair, therefore, requests that this application, both for permission to dually complete and for the establishment of an 80 acre Nonstandard Proration unit in the Elinebry Gas Pool be granted by the Commission.

Schematic Sketch

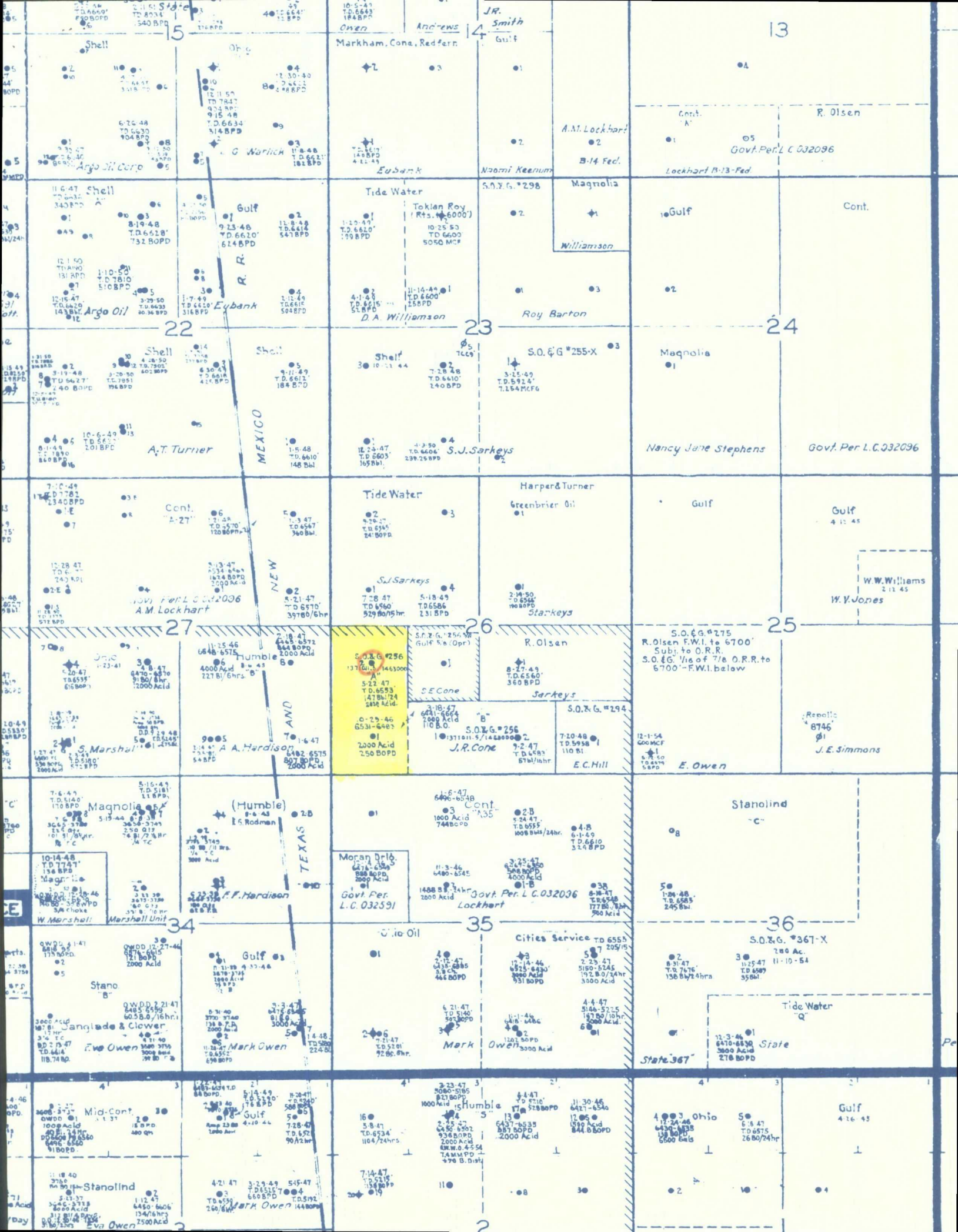
