Gentlemen:

El Paso Natural Gas Company respectfully requests Administrative Approval under the provisions of Rule 5(b) of Order No. R-520 for a Non-Standard Gas Proration Unit of 160 acres, more or less, consisting of the NW/4 of Section 27, Township 25 South, Range 37 East, N.M.P.M., Jalmat Gas Pool, Lea County, New Mexico, and in support thereof states the following facts:

1. That R. Olsen completed the R. Olsen Harrison Federal #2 Well on June 8, 1956. That said well is located 660 feet from the North and West lines of Section 27, Township 25 South, Range 37 East, N.M.P.M. That this well was drilled to a total depth of 3542 feet and was plugged back to 3300 feet and was completed as a gas well in the Jalmat Gas Pool with an initial potential of 5,800 MCF absolute open flow.
2. That by Bill of Sale dated May 25, 1956, R. Olsen sold this well to El Paso Natural Gas Company.
3. That El Paso Natural Gas Company holds the Gas Operating rights under the NW/4 of said Section 27.
4. That the proposed Non-Standard Gas Proration Unit will meet the requirements of Rule 5(b) of Order No. R-520 in that the proposed unit consists of contiguous quarter-quarter sections within a single governmental section, that the length or width thereof does not exceed 5,280 feet, and that the entire area of the proposed unit lies within the horizontal limits of the Jalmat Gas Pool and may reasonably be presumed to be productive of gas.
5. That by a copy of this Letter Of Application, all of the other operators owning an interest in the section in which the proposed Non-Standard Proration Unit is situated and all operators owning an interest within 1500 feet of the well have by registered mail been notified.

6. That a plat showing the acreage to be dedicated to the proposed Non-Standard Gas Proration Unit, the location of the said well, and the offset ownership is attached hereto.

7. El Paso Natural Gas Company intends to use said well as the unit well.

In view of the existence of the facts herein stated and in compliance with the provisions of Rule 5(b) of Order R-520, El Paso Natural Gas Company requests Administrative Approval of said proposed 160 acre Non-Standard Gas Proration Unit.


