We have been informed that you took over on April 1, 1957 from J. H. Moore, the Pech-State Well No. 2, located in the NE/4 SW/4 of Section 32, Township 21 South, Range 36 East, South Eunice Oil Pool, Lea County, New Mexico.

On April 18, 1957 at the request of Mr. J. H. Moore, Administrative Order DC-384 was cancelled by us as it was to be a single completion. A copy of Mr. Moore's letter and our letter is enclosed.

On December 28, 1956, we issued Administrative Order NSP-335 for a 160-acre gas unit consisting of the SW/4 for this well. A copy of this is attached. If this well is to continue only as an oil well in the South Eunice Oil Pool, then would you please request this office to cancel NSP-335 as it likely would not be needed.

Gentlemen:

Reference is made to your application for approval of a 160-acre non-standard gas production unit in the Jalant Gas Pool consisting of the following acreage:

Township 21 South, Range 36 East
NE/4 of Section 32

It is understood that this unit is to be ascribed to your Pool-
State Well No. 2, located 1000 feet from the South line and 1900 feet from
the West line and in the NE/4 SW/4 of Section 32, Township 21 South, Range
36 East, NSPN, Lea County, New Mexico.

By authority granted me under provisions of Rule 5, Section (b)-
6 of the Special Rules and Regulations for the Jalant Gas Pool, as set forth
in Order R-570, you are hereby authorized to operate the above described
acreage as a non-standard gas production unit, with allowable to be assigned
thereto in accordance with Rule 12 of the pool rules, based upon the unit
size of 160 acres after submission of proof of communitization to both the
Santa Fe and Hobbs Offices.
