Gentlemen:

This letter is to request that the Oil Conservation Commission schedule a hearing to consider our Application for Approval of 160 acre Non-Standard Gas Proration Unit, being the W/2 of the SW/4 and the W/2 of the NW/4 of Section 17, Township 22 South, Range 37 East, Lea County, New Mexico, to be assigned to New Mexico State "M" Well No. 12, located 660' from the South line and 660' from the West line of Section 17, Township 22 South, Range 37 East, Lea County, New Mexico. In support of this request we submit the following information:

W/2 W/2

1. New Mexico State "M" Well No. 12 now producing as an oil well from the Queen Zone, Eumont Pool, with an assigned 40 acre unit described as being the SW/4 of the SW/4 of Section 17, T-22-S, R-37-E, Lea County, New Mexico. We plan to work this well over by perforating the gas zone in the Queen Sand and Sand Frac the new perforations with 24,000 gallons of refined oil and 36,000 pounds of sand, in three 8,000 gallon stages.
2. The proposed Non-Standard Proration Unit consists of contiguous quarter, quarter sections.
3. The entire proposed Proration Unit may reasonably be presumed to be productive of gas.
4. The length or width of the Non-Standard Proration Unit does not exceed 5280'.
5. The 160 acre Unit to become effective after approval has been received from the Conservation Commission and the workover completed.
6. A plat is attached of the proposed 160 acre Non-Standard Proration Unit, also a gas well plat and a lease plat showing all offset operators and pertinent lease information.







Gentlemen:

Under date of August 7, 1957, you applied for a hearing to form a 160-acre non-standard gas proration unit consisting of the W/2 W/2 of Section 17, Township 22 South, Range 37 East, in the Eumont Gas Pool. This unit is to be dedicated to your State "M" Well No. 12 located in the center of the SW/4 SW/4 of said section. That subject well is presently an oil well in the Eumont Gas Pool, but is to be recompleted as a gas well in the Eumont Gas Pool.

Under provisions of Rule 5 (a) and 5 (b) of Order R-520 it is possible to grant this application administratively. It will be processed as NSP-389 to be issued on September 11, 1957 providing there are no objections.
