for 120-acre Non-Standard Gas Proration
Unit, Blinebry Gas Pool, Lea County,
New Mexico.

Dear Sir:

Now comes Marathon Oil Company, an Ohio Corporation, with offices at Hobbs, New Mexico, who respectfully requests administrative approval of a non-standard gas proration unit in exception to Rule 5 (A) of Order No. R-1670 pertaining to the Blinebry Gas Pool.

Applicant further states and deposes the following:

1. Applicant is the operator of the oil & gas rights under all of the NW/4 of Sec. 1, T22S R37E, Lea County, New Mexico, said lease comprising 160 acres, more or less, with all mineral rights therein having been communitized by operating agreement and being known as Marathon Oil Company's Walter Lynch Lease.
2. Applicant recompleted their Walter Lynch, Well No. 4 in April, 1954 as a Tubb (Gas)/Blinebry (Gas) dual as authorized by Order DC-69 at a location 660' FNL & 4695' FEL, Sec. 1 T22S R37E, Lea County, New Mexico. The Blinebry perms. (Gas) 5480' - 5675', are within the vertical limits of the Blinebry Gas Pool and since re-completion, the gas and liquid characteristics have been consistently within the limitations as set by Rule 27A, Order No. R-1670.
3. On September 12, 1964 applicant recompleted their Walter Lynch, Well No. 5 located 660' FNL & 1980' FWL, Sec. 1 T22S R37E, Lea County, New Mexico in the Blinebry Oil section through 5 1/2" casing perms. 5689 1/2 - 5839 1/2, setting a production packer between those perms. and the existing Paddock Oil section perms. 5168 - 5183', packer being set at 5689'. On initial potential test September

12, 1964 the Blinebry Oil section flowed 32.44 barrels of oil and 7.11 barrels of water in 24 hours through 20/64" choke. GOR was 2989:1 and gravity of crude was 38.4 API at 60°F.

4. Rule 30 of Order No. R1670 states: "Acreage dedicated to a gas well in the Blinebry Gas Pool shall not be simultaneously dedicated to an oil well in the Blinebry Oil Pool". Accordingly, applicant respectfully requests that the S/2 of the NW/4 and the NW/4 of the NW/4 of Sec. 1, T22S R37E, being 120 acres, more or less, be designated as a non-standard gas proration unit in the Blinebry Gas Pool and assigned to the Blinebry Gas Zone in Marathon Oil Company's Walter Lynch, Well No. 4.
5. Creation of the above proposed non-standard gas proration unit is in the interest of conservation and will protect correlative rights.
6. A plat showing the said Marathon Oil Company's Walter Lynch lease and all wells thereon, the acreage to be dedicated, and offset ownership is attached hereto.

Dear Sir:

Attached hereto is Revised Form C-128 on Marathon Oil Company's Walter Lynch, Well No. 4, Blinebry Gas Pool, indicating 120 acres dedicated acreage, along with Forms C-103, C-104, C-110 and C-128 on Marathon Oil Company's Walter Lynch, Well No. 5, Blinebry Oil Pool.

Walter Lynch, Well No. 5 was completed in Paddock Oil Section in June, 1947 and recompleted on September 12, 1964 in the Blinebry Oil Section. A production packer was set between the Blinebry Oil Section perforations and the Paddock Oil Section perforations.

Rule 30 of Order R-1670 states: "Acreage dedicated to a gas well in the Blinebry Gas Pool shall not be simultaneously dedicated to an oil well in the Blinebry Oil Pool". Therefore, application for administrative approval for a 120 acre non-standard gas proration unit for Walter Lynch, Well No. 4 is being filed this date.

In the protection of correlative rights, we respectfully request that an allowable supplement be issued effective this date reducing the Blinebry Gas Pool allowable for Walter Lynch, Well No. 4 from that of a 160 acre unit to that of a 120 acre unit. We further request that Walter Lynch, Well No. 5 be assigned an allowable, 33 BOPD, for the Blinebry Oil Pool, effective September 12, 1964.
