We forward herewith applications, in triplicate, requesting approval of non-standard gas proration units for our Southeast Monument Unit Wells Nos. 64 and 65, located in Section 26, T-20S, R-37E, Lea County, New Mexico. The acreage in Section 26 had previously been dedicated as follows:

E/2 and E/2 W/2 to Well No. 64
W/2 W/2 to Well No. 65

We now propose to dedicate the acreage in Section 26 as follows:

E/2 to Well No. 64
W/2 to Well No. 65

We request administrative approval of the applica-
tion for Well No. 64 and ask that you set the application for
Well No. 65 for hearing at your earliest convenience.

There are no offset operators so there is no need for a 30-day delay. However, since the transfer of acreage is contingent on the results of a hearing, it will be satisfactory for you to defer administrative approval of the NSP unit for No. 64 until the enlargement of the unit for No. 65 has been approved.

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5(c) of the Special Rules and Regulations for the Eumont Gas Pool of Order No. R-1670 for the formation of a 320-acre non-standard gas proration unit consisting of E/2 Section 26, T-20S, R-37E, for its Southeast Monument Unit Well No. 64, located 1980 feet from the north line and 1980 feet from the east line of Section 26, T-20S, R-37E, Lea County, New Mexico, in the Eumont Gas Pool.

In support of this request we should like to point out that the proposed unit conforms with the requirements of said Rule 5(c) in all respects as follows:

1. Said proposed non-standard gas proration unit consists of contiguous quarter-quarter sections.
2. Said proposed non-standard gas proration unit lies wholly within a single governmental section.
3. The entire proposed non-standard gas proration unit may be reasonably presumed to be productive of gas.
4. The length or width of said unit does not exceed 5,280 feet.
5. There are no other operators in the same section or within 1,500 feet of said well.

A plat is attached hereto showing to the best of our knowledge and belief the proposed unit, the location of the No. 64 well and other wells on the lease, offset wells and ownership thereof.


The granting of this application is in the interest of preventing waste and the protection of correlative rights.
