
Re: Application for Non-Standard

Gentlemen:

Amerada Petroleum Corporation requests that a non-standard gas proration unit be assigned to its State NJ "A" Com. No. 3, located 493' FNL and 690' FEL of Section 2, T-25-S, R-37-E, Lea County, New Mexico. It is requested that the proration unit include all of the NE/4 of Section 2 for a total of 160.24 acres. This well is completed in the Paddock zone in the Justis Gas Pool. Amerada owns all of the working interest to the Paddock zone in the NE/4 of Section 2. The royalty interest is State owned and is to be communitized.


