Dear Sir:

The Atlantic Refining Company is the operator of the Pure Federal No. 1 Well, located in the W/2 of Section 11, Township 21 South, Range 25 East, on a tract of 340.94 acres. It is completed in an undesignated Morrow gas reservoir. We respectfully request an Administrative exception to New Mexico Oil Conservation Commission Rule 104, B, I, requiring wildcat wells drilled to the Pennsylvanian age or older to be located on a drilling tract consisting of 320 surface contiguous acres.

Rule 104, D, II, provides for Administrative approval of this non-standard gas unit without notice and hearing. Enclosed are plats showing all offset acreage ownership and wells completed thereon, and location of the Pure Federal No. 1 and its dedicated acreage. We are notifying all offset operators of this application by registered mail.


