We respectfully submit this application for and request approval of a 120-acre non-standard gas proration unit in the Tubb Gas Pool, Lea County, New Mexico, consisting of the following acreage:

TOWNSHIP 21 SOUTH, RANGE 37 EAST
N/2 NW/4 & SW/4 NW/4 (Unit C, D, E) of Section 36

This unit will be assigned to our State "C" Tract 13 Well No. 5, located 1980 feet from the North line and 660 feet from the West line of Section 36, Township 21 South, Range 37 East, Lea County, New Mexico.

This non-standard proration unit was occasioned by the recent re-completion of our State "C" Tract 13 Well No. 5 in the Tubb formation.

In support of our request for exception approval without notice and hearing to Rule 5 (a) of Order No. R-1670 of May 20, 1960, the following is submitted:

1. This application is submitted in triplicate.
2. This non-standard gas proration unit consists of contiguous quarter-quarter sections and lies within the horizontal limits of the Tubb Gas Pool.
