Dear Mr. Cox:

Rule 3 of the Special Rules and Regulations for the North Bagley-Lower Pennsylvanian Pool requires that all operators offsetting the proposed non-standard unit shall be notified of the application by registered or certified mail, and that the application shall state that such notice has been furnished. Dear Mr. Porter,

At this time I am drilling the John L. Cox - Federal No. 1, located 963 feet from the north line and 1980 feet from the west line of Section 3, T-11-S, R-33-E, Lea County, New Mexico. This lease consists of 49.27 acres, being Lot 3 in Section 3. The well is being drilled to the Pennsylvanian formation in the North Bagley area. Inasmuch as this lease consists of a non-standard proration unit, I would appreciate administrative approval of a proration unit consisting of the lease upon completion of the well that is now being drilled.


