Gentlemen:

It is respectfully requested that administrative approval be given for the drilling of the Midwest Oil Corporation No. 3 South Empire Deep Unit well located 660' FSL and 1980' FWL of Section 31, Township 17 South, Range 29 East, Eddy County, New Mexico in the Empire South (Morrow Gas) Field.


The reason that the herein requested approval is necessary is the fact that there are lots along the west side of section 31 which contain considerably less than 40 acres each. We are enclosing a copy of the surveyor's plat on section 31 upon which we have added the lot numbers and the amount of acreage in each lot.

It can be noted from the plat that the No. 3 well location is only 311.5' from the quarter-quarter section line and that the south one-half of section 31, which has been dedicated to the No. 3 well, only contains 298.56 acres.

The nearest unit boundary to the No. 3 well location is one mile to the west. All of the working interest owners in the unit are committed to the unit.

If the Commission grants administrative approval of this well, Midwest Oil Corporation will want to withdraw application for the hearing on July 26, 1972.




