Henry Petroleum LP would like to re-complete and rename the South Justis Unit "E" # 202 to the W.N. Wimberly #14 (Grayburg). It is in the same proration unit as the W.N. Wimberly #9, making this a non-standard location. We would like to obtain approval for simultaneous acreage and proration for the referenced wells. The description of the two wells follows:
