The permit number is GW-087, Cedar Hill C.S.

The NMOCD have processed the majority of their files for online viewing. These files can be viewed by the applicants and the public. Your discharge permits files may be viewed here:

Once you've accessed the website, look in the left hand column and click on,

"Administrative & Environmental Orders"

Once page is accessed find the **"Specific Information"** (near the top of the page) area and click on the Pull Down menu in **"Order Type"** window, in the menu select **"Discharge Plan Permit - (GW)"**. Find the **"Order Number/Amendment"** block, then type in the GW number (GW-087) in the block. Once typed in click on the **"Continue"** button. That'll take you to your file page.

You will now be at the **"Administrative/Environmental Order Search – Select Documents to View"** page.

Once on this page you will see a display of THUMBNAILS (labeled as Permits, Correspondence, Reports, etc.) Click on each thumbnail to view all information behind them. These Thumbnails may contain several pages behind them.

I am responding to the letter I received 9/8/09 regarding the modification of the Compressor Station at the Cedar Hill Location. I live directly across the street from that and own the land and minerals along and North of C.R. 2300 as well as directly across 550. I have watched the progress of the activity and consequently the degradation of the land and quality of life for 16 years. The land has been in the family since 1926. As it is now, I have intermittent runny eyes, bloodshot eyes, sore throat, headaches (more frequently now than ever before) chest discomfort, and nausea. There are various odors in the air, sometimes so sudden and violently bad that immediate eye, nose and chest irritation and burning occur and we have to go inside. In August of 2007 I had a Huge Ovarian Cyst removed. No other explanations for how it was caused. I believe the chemicals that are pumped, stored, and blown into the air had something to do with it. To read that these emissions are going to be INCREASED is distressing at the very least.

Most of all I would like someone to come out here and inspect the situation that is there already. I do not think anyone has been here in a long time. I sent a letter the last time I got a notice and requested someone at least call and heard nothing. I think this area has slipped between the cracks and needs to be inspected and regulated. I did call and was told they may or may not send inspectors to sites when changes are made. There are wells, rigs and rigging waste, compressors, several ponds, heavy water, just to name a few. The concentration of pollution in this area is out of control. This is all happening above the water table and close to a RIVER as well.

I am requesting that a representative meet me at the site and explain what is going on, as well as what pollutants are present and how they are being handled. I am requesting a copy of the MSDS current levels, not estimates but actual records. I want to know how this new proposal will change these numbers.

Now we also need to address the NOISE! It is out of control as well. It is so loud I cannot sleep at night and my bedroom is on the back of the house facing away from the Compressor Station with the window closed. The days of sitting on the deck and enjoying the quiet are now sadly gone. The noise never stops. Please, Please, PLEASE do noise abatement to reduce the noise as much as possible. People cannot believe the noise when they visit. How loud it is and how much louder it has become over the years.

I want a copy of the preliminary review and it's air quality impacts before it hits the newspaper. When is it going to be in the newspaper? Do we have to check everyday to see what is happening on and near my own land and home?

I will be out of town for family business 9/17/09 through 9/28/09. I will be available anytime other than that. I will be able to be reached on my cell number any time, even while I am gone, so a representative can call and set up a time to meet.
