

This is Shell Oil Company's application for a 40-acre non-standard gas proration unit to be dedicated to Shell's Taylor Glenn No. 3, Blinebry (Gas) Field, Lea County, New Mexico. As shown on the attached plat, this well is located in Unit Letter I, 3546' FNL, 330' FEL Sec. 3, T-21-S, R-37-E, Lea County, New Mexico.

Shell's Taylor Glenn No. 3 was completed in September 2, 1956 as a Blinebry oil producer. It was reclassified as a gas well October 1972 and the well shut in.


