



Gentlemen:

Mobil Oil Corporation respectfully requests administrative approval of a non-standard gas proration unit for the subject well. This well is to be located in Lot 9 (Unit I), 2787 ft from the north line and 860 ft from the east line of Sec. 4, T-21-S, R-27-E, Eddy County, New Mexico. This non-standard unit is necessitated by a variation in the legal subdivision of the U.S. Public Surveys. It will comprise Lots 1, 2, 7, 8, 9, 10, 15 & 16 of said Sec. 4 and it will contain 298.91 acres of land more or less.

In support of this request the following items are being submitted in duplicate:

1. Form C-102 (NMOCC Form) acreage dedication and well location plat. Six certified copies of this form has been filed with the USGS as a part of Mobil's application to drill. It is our understanding that they will forward necessary copies to the NMOCC.
2. Plat showing all of Section 4 and the offset operators and lease owners to Mobil's lease. Mobil's lease is outlined in yellow and the subject well is indicated by a red arrow.
