Approximately 250 bbls. of saltwater were contained inside the diked area around the tank battery and approximately 25 bbls. saltwater got outside of the diked area around the tank battery A vac. truck picked up the saltwater and put approximately 200 bbls. back into the saltwater tank and properly disposed of approximately 75bbls in an offsite commercial disposal well.
