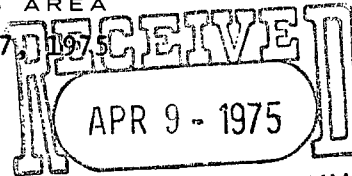

Dear Sir:

Gulf Oil Corporation requests your administrative approval for two separate 80 acre non-standard proration units in the Blinebry Oil & Gas Pool with one unit to be dedicated to our Eaves No. 6, located 554' FNL & 766' FEL and consisting of the E/2 NE/4 and the second unit to be dedicated to our Rollon Brunson No. 4, located 2086' FNL & 1874' FEL and comprising the W/2 NE/4, both in section 10, 22-S, 37-E, Lea County, New Mexico. In support of this application the following facts are submitted:

1. Our Eaves lease is described as the E/2 NE/4 and the Rollon Brunson lease consists of the W/2 NE/4 of said section 10.
2. The Eaves No. 6 well is a marginal well with a 120 acre non-standard proration unit covering the E/2 and NW/4 of the NE/4, section 10. (NSP-557).
3. The Rollon Brunson No. 4 well was recently reclassified as a gas well due to Gas-Oil-Ratio in excess of 50,000/1, necessitating these non-standard units.
4. There are no other wells producing from the Blinebry Oil & Gas Pool in the NW/4, section 10, 22-S, 37-E.
5. The attached plats show the proposed 80 acre non-standard units outlined in red.
6. All offset operators have been furnished copies of these applications.

Your early consideration in this matter will be appreciated.

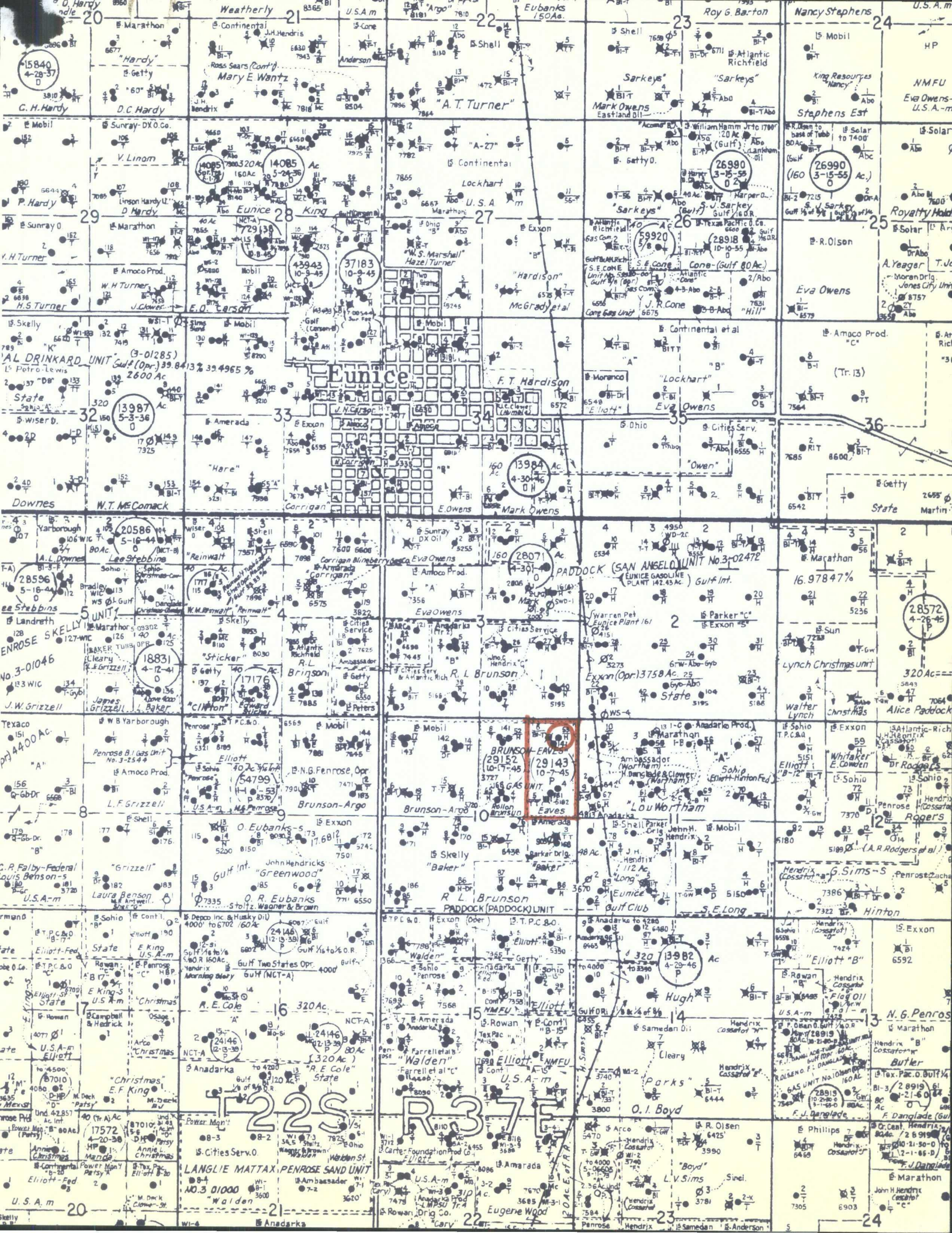
