



This request for administrative approval of a non-standard proration unit for the above-referred-to well is being presented on behalf of the operator, Manning Gas and Oil Company. This request is being presented in accordance with the procedure set forth in Order R-4314.

The subject well is located 845' feet from the North Line, 1190' from the West line of Section 2-T24N-R4W, Rio Arriba County, New Mexico. See attached Well Location and Acreage Dedication Plat.

Due to the configuration of Section 2 and the location of the subject well it would be impossible to establish a 160-acre proration unit without having to exclude a portion of the North-east Quarter of the section which is a legal subdivision.

Therefore, it is requested that the 212<sup>+</sup> included in the North~~west~~ Quarter of Section 2-T24N-R4W be approved as a Non-Standard Proration Unit for the above-referred-to well.
