General Description of Remedial Action: This junction was addressed under the pipeline replacement/upgrade program. A new, watertight junction box was built in place of the former. After the former box was removed, an investigation was conducted using a backhoe to collect soil samples at regular intervals producing a 20x15x12-ft-deep hole. Chloride field tests were performed on each sample, which yielded generally low concentrations. Organic vapors were also measured using a PID, which yielded low concentrations. Representative composite samples were sent to a commercial laboratory for analysis of chloride and TPH, which confirmed low concentrations. The excavated soil was blended on-site and returned to the excavation to ground surface and contoured to the surrounding area. On 8/19/2008, the site was seeded with a blend of native vegetation and is expected to return to a productive capacity at a normal rate.





CHLORIDE CONCENTRATION CURVE


