

The heater at the BC Dickinson D battery blew a 2" welded collar and bull plug out of the bottom of it, (below water leg). The heater treater released 15 bbls of oil and 40bbls of produced water.  
1. NMOCD was immediately notified.  
2. Vacuum was called to the site to clean site  
3. Back hoe and called to site for remediation.

Describe Area Affected and Cleanup Action Taken.\*  
Release breached firewall and went to west side of battery. Most of the fluid stayed on lease road, except for an area of 15X30 ft. Vacuum truck and back hoes were immediately contacted to clean spill and perform remediation work on the site.
