Describe Cause of Problem and Remedial Action Taken.*

A valve on the upstream side of a PD pump for an unattended Injection station picked up water from previous pump activity and froze overnight (sub-freezing temps). At next pump time (04:00 - 10-Jan), the valve piping broke and allowed the discharge of crude oil to the environment until discovered at 07:30 - 10-Jan by the Operator's (XTO) pumper. The system was shut down immediately upon discovery. Remedial activity included recovery of free product (approximately 200 Bbl) via vacuum truck and removal of top layer of contaminated soil placed on plastic on CPPL right-of-way.

Describe Area Affected and Cleanup Action Taken.*

Area is approximately 250 ft. x 25 ft. with soil mostly frozen with some snow. Cleanup of contaminated soil is progressing with contaminated soil placed on plastic and to be disposed of in accordance with NMOCD guidance documents and District oversight.
