The Oil Conservation Division (OCD) received your letter of February 3, 2010, regarding the above referenced well on February 4, 2010. The first one (1) year extension was granted by OCD on March 25, 2009.

It is our understanding that the wells in the area of review (AOR) for this well have not changed since the order was initially issued. Based on this fact, the authority to inject into this well is hereby extended to March 25, 2011. This authority shall expire *ipso facto* if injection operations are not commenced by this date.

Dear Mr. Ezeanyim:

This letter is written to request an additional one year extension to the Canyon SWD #1, SWD-1119 injection permit. XTO Energy, Inc. ("XTO") anticipates having the referenced well completed by March 2010. However, the injection facilities will not be operational by this time. As a result, the additional time is needed commence injection operations.

XTO had no drilling in 2009 for the Area of Review ("AOR"). We drilled two (2) wells in T25N-R11W in 2008 in the Dakota and Mancos formations. The Hun Ne Pah #1F well is on-line and we are waiting on Right of Way to produce the Pah #1E well.

There were no wells drilled in the Mesaverde formation in the AOR nor does XTO see any potential to recover minerals from the Mesaverde formation, as stated in the original application.
