Apache Corporation ("Apache") respectfully requests to revise the non-standard bottom-hole location of the J G Hare #18 well to **1310' FSL & 1330' FWL (Unit Letter N) of Section 33, Township 21 South, Range 37 East, Lea County, New Mexico**. Current non-standard bottom-hole location (1330' FSL & 1310' FWL, Unit Letter L, of same Section 33) for the J G Hare #18 was approved via Administrative Order No. NSL-6145, dated February 8, 2010, covering the Blinebry and Tubb formations.

However, the currently approved non-standard bottom-hole location will not be allowed due to an existing non-standard 80-acre laydown gas proration unit (created by Order No. NSP-735-A) in the Blinebry formation, consisting of the N/2SW/4 Section 33, dedicated to the J G Hare #6 well. In order to avoid a great amount of paperwork, Apache wishes to revise the bottom-hole location of the J G Hare #18 well to the above stated, revised location. Should the J G Hare #18 well produce as a Blinebry gas well, Apache will immediately file for a non-standard 80-acre gas proration unit, consisting of the S/2SW/4 Section 33, to be dedicated to the proposed well.

Apache owns 100% leasehold interest as to the Blinebry and Tubb formations in the entire SW/4 of said Section 33-T21S-R37E. Therefore, no other parties will need to be notified of this change.
