Dear Mike,

Per our phone conversation on Friday, this email will serve as an amendment to the Site Clean-up Summary and Remediation Work Plan dated August 10, 2009. 20-30% of the most highly impacted soil will be hauled for disposal at CRI, Inc. Blending testing will be performed on the remaining to determine the ratio of contaminated soil:clean soil to achieve the projected Total Petroleum Hydrocarbons (SW Method 8015) less than 5000ppm, BTEX less than 50 ppm (Method 8021B) and chlorides (EPA 300) less than 1000 ppm. Actual blending will be based on test blending results. Final sampling will be performed on the blended soil and samples tested for TPH and chlorides. Upon results from the laboratory confirming the TPH less than 5000ppm, BTEX less than 50, and chlorides less than 1000ppm the soil will be placed back in the excavated area.

Upon review of the plan, would you please give us approval or recommendations for amendments?
