Apache requests administrative approval to surface commingle the following existing wells, DC Hardy #3, #4, #5, #6, #7, #8, #9 and #10 with the DC Hardy #11, a new drill. The DC Hardy #11 will be a Blinebry/Tubb/Drinkard/Abo well.

All wells are located on the same Private Lease #16814. All working, revenue and royalty interest ownerships are common in all wells except for the DC Hardy #11.
