Reference is made to the following:

(a) your application (**administrative application reference No. pTGW10-06752158**) submitted to the New Mexico Oil Conservation Division (the Division) in Santa Fe, New Mexico on March 8, 2010,

(b) your supplemental email dated March 15, 2010, and

(c) the Division's records pertinent to this request.

COG Operating, LLC [OGRID 229137] (COG) has requested to drill the above-referenced well at an unorthodox oil well location, described above in the caption of this letter. The SE/4 NW/4 of Section 16 will be dedicated to this well in order to form a standard 40-acre oil spacing and proration unit in the Grayburg Jackson-Seven Rivers/Queen/Grayburg/Glorieta/Yeso Pool (97558). This pool is governed by statewide Rule 15.9.A, which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary. This location is less than 330 feet from the western unit boundary.

Your application has been duly filed under the provisions of Division Rules 15.13 and 4.12.A(2).

It is our understanding that you are seeking this location to avoid interference another existing well. It is also understood that you are cancelling your approved APD for the GJ West Co-op Unit Well No. 221 (API No. 30-015-37569) so that there will not be more than four Grayburg Jackson wells in this spacing unit


It is further understood that notice of this application to offsetting operators or owners is unnecessary due to common ownership.
