The New Mexico Oil Conservation Division (OCD) has received the Abatement Plan (AP-48) Addendum for the Justis Jct L-1 Site, dated October 4, 2010, and subsequent information, dated October 22, 2010, has conducted a review of the proposed Addendum. The Amended Plan indicates that Rice Operating Company (ROC) has met the requirements of OCD Part 30 (formerly, Rule 19) for a Stage 1 & 2 Abatement Plan. Therefore, the OCD hereby conditionally approves the Abatement Plan (AP-48) Addendum for above-referenced sites in accordance with 19.15.30.16 NMAC:

- ROC must commence the proposed corrective actions within 30 days.
- ROC must ensure that any treated groundwater used to promote vegetative growth at the site meets the WQCC standards for groundwater.
